2. No metals, recyclables or brush shall be mixed or deposited in a debris load. _____ (**initial**)
3. Truck/dumpster shall not be loaded higher than the sides or extend past back of tailgate /door.
4. Tailgate/door and all other movable parts of truck /dumpster shall not be adjusted by users.
5. No person shall stand on, or place any objects on hood, roof, mirrors or any other location of truck other than inside the dump body.
6. I understand that the village truck /dumpster will not be delivered if deposit and disposal fee have not been paid for in advance of requested date.
7. I understand that the truck /dumpster must be off the street for any overnight use and can not be moved until scheduled picked up by village DPW employee.
8. I understand ALL OF THE ABOVE, and that my deposit will not be refunded by the Village, if DPW is required to go thru truck/dumpster to remove items or correct the loading before taking to the dump. _____ (**initial**)

having requested the placement of a Village of South Nyack vehicle/dumpster on my premises for the purpose of depositing therein certain debris, rubbish and waste materials, hereby agree as follows:

1. I will not enter upon said vehicle/dumpster nor permit any person to enter upon said vehicle except for the stated purpose of depositing therein certain debris, rubbish and waste materials;
2. I will not move said vehicle/dumpster nor permit any person to move said vehicle other than a duly authorized employee of the Village of South Nyack
3. I will not deposit into said vehicle/dumpster any toxic, radio-active or other hazardous materials or metals of any kind;
4. I will indemnify and hold the Village of South Nyack, its officers, employees and agents harmless against any claims for personal injury or property damage that may be made by myself or any third parties resulting from the use of the vehicle/dumpster;
5. I will indemnify and hold the Village of South Nyack, its officers, employees and agents harmless against any damage to the vehicle/dumpster that may occur during the period that the vehicle is situated on my property;
6. I will indemnify and hold the Village of South Nyack, its officers, employees and agents harmless against any costs that that may be incurred resulting from the deposit of toxic, radioactive or other hazardous materials into said vehicle during the period that the vehicle/dumpster is situated on my property;
7. I agree to comply with the rules and regulations for the use of the vehicle/dumpster set forth on the attached sheet.

THE REFUNDABLE DEPOSIT OF \$250.00 MUST BE PAID TO THE VILLAGE PRIOR TO USE OF THE VILLAGE TRUCK/ DUMPSTER AND ALL OTHER REGULATIONS STILL APPLY.
