Dear South Nyack Residents,

On Tuesday, December 1st, all residents of the Village are invited to a special meeting of the South Nyack Village Board. Concepts developed in conjunction with the Thruway Authority for the New NY Bridge shared use bike/pedestrian path and parking options will be presented and reviewed by our Tappan Zee Bridge Task Force. These concepts attempt to preserve the residential nature of our village.

This meeting will be held at the Living Christ Church and will begin at 6:30pm. The Tappan Zee Bridge Task Force will report on the progress made over the past several months working in collaboration with Governor Cuomo's office and the Thruway Authority. As you know, the Task Force succeeded in their efforts to have the terminus of the path moved away from the corner of Cornelison and South Broadway and into Thruway property at Exit 10. Several new concepts to accomplish this will be presented to the Village Board and the public. We hope many residents will attend this special meeting.

The Living Christ Church is located at 151 South Broadway, at the corner of Voorhis Avenue.

# POLICE

### **Yielding To Pedestrians**

Recently, we have received some inquiries at the Police Department regarding the laws that govern crosswalks. New York State Vehicle and Traffic Laws (NYS VTL) state that if a pedestrian is within a

crosswalk that is *not* governed by a traffic control device (i.e. Traffic Signal), motor vehicles shall yield the right of way to said pedestrian(s) by way of either slowing down or stopping, if need be. All motorists should be aware of designated crosswalks, particularly ones at intersections with no traffic control devices. They generally are denoted by bright yellow pedestrian crosswalk signs. It is a violation to not yield to pedestrians in these areas, which could be punishable by a fine of up to \$150 and three (3) points on your driver's license.

Additionally, the NYS VTL states that, "No pedestrian shall suddenly leave a curb or other place of safety and walk or run into the path of a motor vehicle which is so close that it is impractical for the vehicle to yield". Pedestrians should use caution when entering crosswalks to insure that they are offering any oncoming vehicles enough time to properly and safely stop.

Common sense and courtesy goes a long way to quell potential vehicle/pedestrian disputes, especially in neighborhoods with high levels of pedestrian traffic, such as South Nyack, Grand View and the surrounding Villages.

### **Historical Signs Grant**

The Village of South Nyack has been awarded \$5,200 by the Greenway Conservancy Trail Grant program for historical signs, to be placed primarily along the Esposito Trail. The trail is on the path of the old Erie Railroad & signage will focus on the railroad's impact upon local commerce and culture. Dedicated volunteers of the Historical Society of the Nyacks and the Piermont Historical Society are helping to compile information that will be included. ### HOUSE NUMBERS: CAN EMERGENCY RESPONDERS FIND YOU?

To assist Emergency Responders (Police, Firemen, Ambulance Drivers) ....and for your safety....it is important that house numbers are clearly visible from the street. On homes, numbers must be a minimum of 3 inches in height. If your house is set back more than 50 feet from the street, numbers must be placed so they are visible from the street, for example on a mailbox, fence, etc.

\*Loose leave pick-up will end earlier if there is a heavy snow storm. Don't wait. Rake your leaves to the curb now!

<u>Place Loose leaves</u> in the gutter in a wind-row for pick-up by the DPW vacuum. The leaves must be free of sticks, rocks and trash. It is the homeowners responsibility to inform their landscape contractor of village requirements.

Grass clippings and other yard debris should be put in bio-degradable bags and placed on the grass between the sidewalk and the curb. Be sure that the bags are free of sticks, rocks and garbage. Bio-Bags are available at the Village Hall.



### EARLY REMINDER FROM THE DEPARTMENT OF PUBLIC WORKS

### Winter Snow Removal:

- So that roadways can be plowed, all vehicles, by law, must be off the street within 2 hours after a snow storm has started. (If snow is predicted, the police will not grant permission for over-night street parking.)
- Homeowners are required to have all sidewalks abutting their property cleared within 24 hours of the end of the snowfall.
- Snow is not to be plowed, shoveled or blown into the street. Please inform the person who plows or shovels for you.
- If possible, wait to clear snow until after the storm has ended. It is the policy of the DPW to plow curb-to-curb. This clean-up takes a few hours after the snow has stopped.
- When clearing your driveway, pile the snow to the right of the direction of traffic flow so that the mound does not get pushed back into the driveway by the Village plow.
- Help your neighbors and the Fire Department by clearing the snow from around any fire hydrant near your home.





### Styrofoam - Recycle or Toss?

Styrofoam or, as it should more correctly be called - expanded polystyrene (EPS) - is an instantly-recognized, usually white-colored product that is part of our everyday lives. From packing peanuts to egg cartons, take-out food containers, foam coffee cups, and supermarket meat trays, EPS is in high-demand. But, what is it and can it be recycled in Rockland County?

Derived from crude oil, EPS is a highly-flammable plastic that does not readily biodegrade. Due to its low density it is easily carried by the wind. It is a main component of plastics pollution in the oceans and is hazardous to marine and bird life. It can be lethal if animals mistake it as food. Studies also indicate that EPS may contain carcinogens.

New York City has banned its use in the food service industry, as have hundreds of other cities across the globe.

EPS is about 98% air. The light weight of EPS products makes them difficult and uneconomical to collect. Despite its bad environmental record, EPS is recyclable and has recycle symbol #6. Yet, few facilities are set up to accept it. The nearest EPS recycling collection point is at the Yonkers Recycling Center, but non-residents are barred from using that facility. Some major manufacturers will accept EPS packaging material back for recycling.


EPS is not recyclable at the Rockland County recycling facility, unfortunately. Please do not place any EPS product in your curbside recycle bin. If the use of an EPS product cannot be avoided, please put it in your trash bin and ensure that it will not blow away in the wind. During Summer 2015, our village DPW installed two recycle bins in Franklin Street Park. Painted blue and clearly labelled, the bins are designed to accept bottles and cans and are placed next to existing trash cans near the picnic tables. A third bin is to be installed at the southbound bus stop on the corner of Cedar Hill Ave and South Broadway. Recyclables collected will be taken to the county's Materials Recovery Facility in Hillburn on Thursdays.
